- The contractor may apply for the award of the contract, who:
  - a) are not subject to exclusion under art. 24 par. 1 and par. 5 Public Procurement Law Act
  - b) they fulfill the conditions for participation in proceedings relating to their economic or financial standing and technical or professional capacity
- 10. Grounds for exclusion:

The Purchaser shall exclude from the conduct of contractors pursuant to Art. 24 par. 1 The Public Procurement Law Act. In addition, the Purchaser provides for the exclusion of the contractor under Art. 24 par. 5 Public Procurement Law Act.

- 11. Economic and financial situation:
  - a) The Contractor is insured against civil liability in the scope of conducted activity connected with the subject of the order for the gross amount of 100
  - b) has a financial means or a credit capacity of EUR 100 000 gross
- 12. Technical ability and professional qualifications.
